

TERMS AND CONDITIONS OF PARTICIPATION AND DATA PROTECTION
For the HiKOKI promotion free MultiVolt battery BSL36A18X*
October 15, 2025 – March 31, 2026

* for selected HiKOKI cordless power tools listed below in III. Section 2 (“promotional devices”)

I. Conditions of participation and organizer

- I. Participation in the HiKOKI promotion offering a free MultiVolt BSL36A18X battery for selected HiKOKI cordless power tools (hereinafter referred to as the “promotion”) is subject exclusively to the terms and conditions set out below.
- II. The organizer of the campaign is

- III. The promotion is not affiliated with Instagram, Facebook, or any other social media platform and is in no way sponsored, endorsed, or organized by them.
- IV. By participating in the promotion, you automatically accept the terms and conditions.

II. Eligible participants¹

Eligible to participate are persons who are at least 18 years of age at the time of their participation in the promotion and who have their permanent place of business or residence in the Federal Republic of Germany, Luxembourg, or Austria. Wholesalers and retailers are not eligible to participate. Employees of the organizer and its affiliated companies, as well as their relatives, are excluded from participation. Participation with fake identities or fake documents (including multiple use of documents) with third-party identities is not permitted. Automated participation (e.g., via participation and registration services) is also not permitted.

III. Procedure

1. During the promotional period from October 15, 2025, 12:00 a.m. to March 31, 2026, 23:59 (“promotional period”) from a retailer in UK and ROI and must then register it on the HiKOKI service portal by March 31, 2026, at the latest. Registration must also take place no later than 4 weeks after the date of purchase. During registration, the proof of purchase must be uploaded and the promotion code “Battery2025” and the machine serial number must be entered. The participant will then receive a free MultiVolt BSL36A18X battery worth £91.66 excluding VAT or £109.99 including VAT (manufacturer's RRP) free of charge. The MultiVolt BSL36A18X battery will be shipped free of charge, usually within 20 days of successful registration, to the address in UK or ROI provided by the participant during registration. Each participant is entitled to register a maximum of 5 eligible tools during the promotional period. The organizer will pay the tax on the bonus gift. Any further agreements between the participant and the organizer, as well as between the participant and the retailer from whom the cordless power tool was purchased, remain unaffected by this. This promotion is valid only while supplies last.

¹ Note: For reasons of better readability, the masculine form is used in this document. All references to persons apply equally to all genders.

- It is the participant's responsibility to find out whether the cordless power tool purchased is a promotional item. A list of participating promotional items is provided in the terms and conditions of participation. You can also ask the retailer whether the item is a promotional item. - The following information is required from the participant for processing: first name, last name, address, company (if applicable), email address, invoice, and serial number of the device. The participant is responsible for the accuracy of his/her information.
- Cash payments, self-collection, or exchanges of the free MultiVolt BSL36X18A battery are not permitted.
- If circumstances arise for which the organizer is not responsible, the respective participant shall accept a reasonable replacement.

V. Disclaimer

No responsibility is accepted for data loss resulting, for example, from technical defects during data transmission, damaged, lost, or delayed submissions, or network, hardware, or software problems.

VI. Exclusion

1. The organizer has the right to exclude participants from the promotion and from future participation in such promotions who manipulate the participation process, culpably violate the conditions of participation, etc. This applies in particular if the participant provides false information, publishes content (e.g., comments) that violates applicable law, infringes the rights of third parties or the rights of the organizer, or otherwise attempts to influence participation in an unfair or unauthorized manner. The same applies to comments that can be considered to glorify violence, be discriminatory (based on personal characteristics, religion, or gender, etc.), racist, offensive, harassing, or derogatory, or that otherwise violate social decency.
2. Furthermore, the promotion applies exclusively to registrations by end customers. Registrations via a specialist retailer or using the address of a specialist retailer are excluded from the promotion.

VII. Premature termination of the promotion and changes to the conditions of participation

1. The organizer reserves the right to cancel or terminate the promotion in whole or in part. The organizer will make use of this option in particular if, for certain reasons, such as technical or legal reasons, the proper and regular execution of the promotion cannot be guaranteed.
2. The organizer also reserves the right to change or supplement the conditions of participation at any time without giving reasons, insofar as this is necessary in the interests of simple and secure processing and, in particular, to prevent misuse or for other reasons.

VIII. Legal recourse

Legal recourse is excluded.

IX. Applicable law and place of jurisdiction

1. These conditions of participation and the entire legal relationship between the participant and the organizer are governed exclusively by the laws of the United Kingdom.
2. The exclusive place of jurisdiction is Southampton, UK.

X. Severability

Should individual provisions of the conditions of participation be or become invalid, the validity of the remaining conditions of participation shall remain unaffected.
